128th ANNUAL GENERAL MEETING HELD ON 30th September, 2024 Declaration of Results of Remote e – voting and e – voting at the meeting.

As per the provisions of the Companies Act, 2013, the Company had provided the facility of remote e – voting and e – voting at the meeting to the Shareholders to enable them to cast their vote electronically on the resolutions proposed in the Notice of the 128th Annual General Meeting [AGM]. The remote e – voting was opened from 9.00 a.m. (IST) on Thursday, 26th September to 5.00 p.m. (IST) on Sunday, 29th September 2024.

In line with the provisions of the Companies Act, 2013 and in terms of the clarification issued by MCA, voting by Show of Hands was not permitted at the general meeting, where e – voting has been offered to the Shareholders. Therefore, at the 128th AGM voting was conducted by means of remote e – voting and e – voting at the AGM.

Mr. Ashok Kumar Daga, Practicing Company Secretary was appointed as the Scrutinizer by the Board of Directors for remote e – voting and e – voting at the meeting. The Scrutinizer has carried out the scrutiny of all the electronic votes received up to the close of remote e – voting period on 29th September, 2024 and e – voting received till the conclusion of the meeting on 30th September, 2024 and submitted their Report on 1st October, 2024.
